Summary of PA Inheritance Tax • There is no PA gift tax • But gifts made within one year of death > \$3,000 per calendar year are included in estate • If gifts are spread over two calendar years, you can get two \$3,000 exclusions • Cautions: - Carryover basis for Federal income tax • Save 45% inheritance tax, but pay 20% + 31%
